1. That the Society (Management) should abide by the rules and regulations made in the Government Order 3rd cited & 4th cited.
2. That they compulsorily provide fire extinguishers and fire fighting equipment as prescribed in the National Building code of India part IV fire protection 1997 and approved by fire service department of the state.
3. That the Society may apply for recognition by fulfilment of the all the conditions and shall submit on or before Academic Year **2018-2019**.
4. That the permission accorded is restricted for this year i.e., 2017-2018 only and it is not valid for the **subsequent academic years**.
5. That the permission does not confer any right to society for claiming recognition.
6. The permission is now accorded to open in the school premises the locality and there shall not be any change in the premised or locality.
7. The society should provide necessary material even if it consists more than deposited amount
8. The management should follow all the conditions stipulated in the ref 1st & 2nd cited.
9. 50% of fee collection should be utilized for payment of staff salaries.
10. Maintain first aid kits in sufficient numbers in the school premises.

ORDER:-

The District Educational Officer, Vizianagaram has verified the application for Renewal recognition to Gurajada School, Cantonment, Vizianagaram (M), Vizianagaram District under Mythri Educational Society with reference to the inspection report of the inspecting officer and also with reference to the conditions laid down in the permission already accorded for classes I to V (EM) as per existing rules.

And also after careful examination of the reference cited and the conditions prescribed in G.O.Ms.No.1 Education, Dt.01.01.1994, G.O. 2nd cited and also subsequent government orders from time to time, the competent authority is hereby accorded Renewal of recognition to Gurajada School, Contonment, Vizianagaram(M), Vizianagaram District under Mythri Educational Society for a period of 10(Ten) years commencing from the academic year 2018-2019 to 2027-2028 for classes I to V (English Medium) subject to fulfilment of the following conditions without Grant in Aid.

1. That the Educational Institution should abide by the instructions/ rules and Regulations made by the Government or authorised officer time to time.
2. That the Educational Institution should observe the needs of the locality more particularly.
3. That the Institutions should adopt the curricula and Syllabus prescribed from time to time.
4. The School timings, vacations and mid-term holidays should be as prescribed by the Government from time to time.
5. That the qualified staff within the age limits prescribed by the Government employees should be appointed as per the staff pattern and the appointment should be made as per G.O.Ms.No.1 Edn.(PS.2) Dt.01.01.1994.
6. That the results of Institutions should be satisfactory every year.
7. That the list of Governing body should be furnished to the District Educational Officer every year
8. That the records / accounts should be furnished to the District Educational Officer every year by 31st of May of the latest.
9. That the pay structure/ fee structure fixed by the Governing body should be get approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.Os and other orders which are not specified in this order should be complied with.
11. That the school should not be closed without giving notice both to the parents /DISTRICT EDUCATIONAL OFFICER, and competent authority at least 6 months before.
12. That the school should be closed or permitted to be closed only from the date on which summer vacation declared.
13. That the society should submit proposals for renewal of recognition sufficiently in advance i.e. at least 6months before prior to the date of expire of this recognition.

14. The management should constitute the Governing Body as per the rule 15 of G.O.Ms.No.1 Education, Dt.01.01.1994.
15. The Management should provide adequate, Library books, TLM furniture to the school.
16. The Management should observe clean & Green and Implement Government instructions.
17. The Management should replace the unqualified teachers if any with Qualified persons.
18. The Endowment Grant should be converted into Joint account in favour of the DISTRICT EDUCATIONAL OFFICER and Correspondent.
19. The economic strength should be maintained in every class.
20. That the Institution shall provide fire safety measures in the school as per the No objection certificate from time to time up to the every year of recognition period ends.
21. That the management is informed that no thatched roof accommodation is allowed to run the school.
22. Proper and adequate sanitation facility shall be provided for students especially for girl students.
23. Proper and adequate safety measures shall be taken for children with in the school campus and also near the school premises.
24. The School shall follow traffic and safety guidelines indicated by the Police and fire services departments.
25. The School shall have first aid kit and the teachers shall be trained in first aid.
26. The Correspondent of the school concerned is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
27. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year.
28. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Edn., dated: 06.08.2009 regarding fee structure in private schools.
29. The management should fulfil all the conditions stipulated in RTE Act.
30. The management should renew the NOC of the fire service every year otherwise recognition will be cancelled henceforth.
31. The Management should submit audit report in every year to the undersigned.

- 06 That the results of institution shall be satisfactory every year.
- 07 That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 08 That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 09 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 That all the conditions prescribed in the said G.O.'s and other orders which are not specified in this order shall be complied with
- 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
- 14 That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 15 The management is informed that no thatched roof accommodation is allowed to run the School.
- 16 The management shall provide proper adequate Toilets / sanitation facility to the students & Staff.
- 17 Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises.
- 18 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 19 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students.
- 20 The school shall have first aid kit and the teachers shall be trained in first aid.
- 21 That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
- 22 The management of the school is hereby informed to renew sanitary certificate from the competent authority ever year and same should be submitted to the District Educational Officer, Srikakulam through the inspecting officer.
- 23 The management of the school is hereby instructed to renew the Fire NOC every year without fail.
- 24 That the management shall ensure the Accounts of this school are audited by an authorized Chartered Accountant every year.
- 25 That the management has to maintain trained and qualified of APTET Teachers at all time.
- 26 The Management is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.

If the management fails to comply with the above conditions promptly the Recognition now granted will be reviewed.
